



## Humble Security and Trading Terms and Conditions

BY JOINING HUMBLE SECURITY AND TRADING YOU AGREE TO COMPLY WITH THE FOLLOWING TERMS AND CONDITIONS.

### 1 General Terms

#### 1.1 Acceptance

These terms and conditions (“T&C”) control your Membership in Humble Security and Trading and by accepting these T&C; you agree that you have read and understood these T&C and that your Membership in Humble Security And Trading shall be subject to the following terms and conditions between you as an Associate and Humble Security and Trading. These T&C are subject to change without prior notice.

#### 1.2 Terms of participation and general rules

To be accepted as an Associate, you must be at least 18 years of age and have reached the age of majority in your state of residence. You are only allowed to sign up for one Membership. To become an Associate, you must provide accurate, complete and updated registration information, including an accurate name, phone number and email address. Associate may not (i) select or use an email address of another person; (ii) use a name subject to rights of another person without authorization from that person; (iii) use a false or misleading name, mailing address, or email address to activate or use an Associate account. If you choose to break any of these guidelines, you risk losing your status as an Associate of Humble Security and Trading and you may lose any value or profit you have accumulated in Humble Security and Trading. Humble Security and Trading may require that you verify your identity by asking for certain documents and/or affidavit. By signing up for a Membership in Humble Security and Trading, you as the Associate is opting-in to receive other special offer e-mails from Humble Security and Trading. If you do not wish to receive these e-mails, you may cancel your account at any time. Your membership is personal and you cannot sell it or transfer the Membership without prior written consent by Humble Security and Trading. Humble Security and trading reserves the right to track Associate's activity by both IP address as well as individual browser activity. Humble Security and Trading may reject your Membership registrations or activation without giving any reason for rejection.



### ***1.3 Access to back-office***

As an Associate in Humble Security and Trading you will be allowed to log in at your back-office at the website <https://www.humbletradingsec.co.za> the (“Back-Office”). In the Back-Office you will find information about Humble Security and Trading and the opportunities that Humble Security and Trading from time to time offers to the members, note “all” participating members voluntarily contribute funds so that they can benefit depending on the duration a member chooses. All matured funds at Humble Security and Trading will be paid to beneficiaries in not more than 20 working days. For more information, book an appointment at our website or use the hotline number. We would appreciate if you do not sign up or contribute any funds if you will not abide by the terms and conditions of Humble Security and Trading. In a system of this nature, delays are expected from time to time.

### ***1.4 E-Mail: Electronic communication***

When you are approved as an Associate with Humble Security and Trading you expressly consent to receive any notices, or go to our site <https://www.humbletradingsec.co.za>, under Notices for announcements, agreements, disclosures, reports, documents, communications concerning new products, services, Humble Security and Trading or other records or correspondence from Humble Security and Trading. You consent to receive notices electronically by way of transmitting the notices to you by email using the email address you have registered with Humble Security and Trading.

### ***1.5 Suspending the Membership***

Humble Security and Trading has the right, in its sole discretion, to suspend or cancel, at any time and for any or no reason, an Associate’s Membership and access to the Humble Security and Trading website and Back-Office. In such an event, all balances, and/or contributions will be subject to suspension.

### ***1.6 Termination of access or Membership***

The Associate can at any time terminate the Membership by giving 21 day notice, and a penalty of 15% is required. Notify Humble Security and Trading about the termination of membership by visiting our nearest office or find our office number on our website. Humble Security and Trading can at any point take a decision to terminate your Membership without giving any reason for the termination. The termination will be effected immediately. Please note that if it comes to our attention that you have signed up for more than one Membership and used other e-mail addressed for your registrations or in any other way tried to circumvent the regulation of one Membership only, Humble Security and Trading will immediately terminate all but one Membership. Humble Security and Trading may also delete any Membership to comply with



applicable laws, protect its property or the property of others, ensure the safety of Humble Security and Trading and others or if Humble Security and Trading reasonably determines that a registrant has or is likely to engage in any activity that violates these T&C.

### ***1.7 Legal action***

If you as an Associate violate these Terms & Conditions, Humble Security and Trading without prejudice to any other rights and remedies at law or in equity, reserves the right to take any action it deems appropriate, including but not limited to issuing warning letters, suspending or terminating the Membership, as per above. Furthermore, Humble Security and Trading has zero tolerance for unprofessional behaviour that can in any way, shape or form directly or indirectly harm Humble Security and Trading. Legal action will be taken against those individuals for any loss of income or any other financial losses caused to the Humble Security and Trading or Humble Security and Trading Company due to this behaviour. Any Associate caught smearing the name of Humble Security and Trading – whether it is directly or indirectly, or in any way misrepresent Humble Security and Trading or its company, will also be subject to legal action. Humble Security and Trading shall be the sole determiner in cases of suspected abuse, fraud, violation of its rules, unprofessional behaviour, smearing or misrepresenting Humble Security and Trading. Any decision Humble Security and Trading makes relating to the cancellation of earnings and the termination of membership shall be final and binding.

### ***1.8 Amendments***

Humble Security and Trading may modify these terms and conditions at any time. Please review the T&C from time to time since your on-going use is subject to the T&C as modified. Your continued log-in at your Back-Office or other kind of participation in Humble Security and Trading after such modification shall be deemed to be your acceptance of any such modification. If you do not agree to these T&C, please do not register to become a member of Humble Security and Trading.

### ***1.9 Proprietary rights in website***

Terms & Conditions will be forfeited and legal proceedings may be taken against you. Such unauthorised use may also violate applicable laws including copyright and trademark laws and applicable communications regulations and statutes. Unless explicitly stated herein, nothing in these Terms & Conditions for a sole member shall be construed as conferring any license to intellectual property rights, whether by implication or otherwise.

### **1.10 Legal & Tax compliance**

You are subject to all laws of the state, province and/or country in which you reside and from which you access Humble Security and Trading's website and you are solely responsible for obeying those laws. If Humble Security and Trading suspects that you breach against any law e.g. produce false gift certificate, use a stolen credit cards, or otherwise makes a fraud or an attempt to fraud or any other negativity, Humble Security and Trading can with immediate effect suspend you, block all your earnings and take other legal action against you without further notice. You agree that Humble Security and Trading cannot be held liable if laws applicable to you restrict or prohibit your participation.
